Official Rules

1. This sweepstakes is sponsored by Woodbridge Home Exteriors, Inc. and Woodbridge Home Exteriors of Kansas, Inc. (“Woodbridge”).
2. Woodbridge will award one (1) \$10,000 Home Makeover at the end of the prize period. The prize period begins on January 1, 2015, and ends on November 30, 2015. The winner will receive \$10,000 in Woodbridge product towards a Home Makeover. Woodbridge’s computer shall be the official time-keeping device for this sweepstakes. The prize winner will be determined from a random drawing of all entries received during the prize period. The random drawing will be conducted on or about December 15, 2015. Limit one prize per entry. The odds of winning a prize is determined by the number of entries received prior to the time of the prize drawing. Woodbridge reserves the right at its sole discretion to suspend, modify, or terminate this sweepstakes without notice at any time. The prize winner will be notified by certified mail within fifteen (15) days of the drawing. Return of a prize notification as undeliverable will result in disqualification and selection of an alternate winner. All prizes will be awarded.
3. You may enter this sweepstakes by (i) completing an entry form and returning it to the drop box where you obtained it, (ii) completing an online entry form submitted through Woodbridge’s website www.woodbridgeclassic.com or (iii) printing your name and your complete address on a 3” x 5” card, writing the words “Woodbridge Home Exteriors, Inc., “\$10,000 Home Makeover” at the top, and mailing the card to Woodbridge at 4519 Sigma Rd Dallas, TX 75244. Sweepstakes entrants must (i) be eighteen (18) years of age or older as of the time of entering this sweepstakes and (ii) the titled homeowner for the home address listed on the entry form, which home is in a suitable condition (as determined by Woodbridge or its designees) for installation of the prize (including being in compliance with local building codes and regulations; no water, mold, structural damage). Any waterproofing, remediation or other repairs necessary for proper installation (as deemed by Woodbridge or its designees in their sole discretion) must be performed at the Grand Prize winner’s expense prior to installation. Employees, officers, and directors of Woodbridge, its affiliates, subsidiaries, co-branded partners, consultants, contractors, advertising, public relations, promotion, fulfillment and marketing agencies, and their immediate families (and those living in their same households) are not eligible to participate in this sweepstakes.

maximum retail value of the Grand Prize is \$10,000. The cash value of the Grand Prize is \$10,000. The \$10,000 includes the cost of labor and material. Installation must be provided by Woodbridge's personnel or designee. Woodbridge's personnel or designee shall obtain any required permit to perform the installation. All expenses not specifically provided for are the sole responsibility of the prize winner. Prize is not transferable by the prize winner. Prize is subject to availability. Acceptance of a prize may require entering a standard contract or purchase order for the goods and services to be provided, as required by state law.

By participating in this sweepstakes, each entrant agrees to release, discharge, and hold harmless Woodbridge, its affiliates, co-branded partners, subsidiaries, retailers, agencies, and their respective officers, directors, employees, and agents, from any damages that may arise out of participation in the sweepstakes in any way or out of the acceptance, use, misuse, or possession of a prize. By entering into this sweepstakes, each entrant agrees that any and all disputes, claims, or controversies (hereafter referred to as a "Claim") arising under or relating to this sweepstakes, including the validity or enforceability of this arbitration provision, shall be subject to binding arbitration to be determined by one (1) arbitrator, in accordance with and pursuant to the then prevailing Consumer Arbitration Rules of the American Arbitration Association ("AAA"), to be held and arbitrated in the judicial district in which the entrant lives at the time of his or her entering into this sweepstakes. Each entrant agrees that he or she will not assert a Claim on behalf of, or as a member of, any group or class. The findings of the arbitrator shall be final and binding on all parties. Each party shall be responsible for its own fees and costs. This agreement to arbitrate, and any award or verdict will be specifically enforceable under the prevailing law of any court having jurisdiction. Notice of the demand for arbitration will be filed by the party asserting the Claim with AAA. The demand for arbitration shall be made within a reasonable time after the Claim in question has arisen, and in no event shall any such demand be made after the date when institution of legal or equitable proceedings based on such Claim would be barred by the applicable statute of limitations. Any arbitration proceeding and any award or verdict shall remain confidential between the parties and shall not be made public.
